- Until AP V7 only a hard-coded Evaluation of Search Field, RegEx/Fieldformat without Spaces was possible
- Within AP V8 there are different Training Modes that can be combined:
 - Extracts text based on trained RegEx
 - Extracts text based on trained Bounding Box
 - Extracts text based on Search Field Settings of the trained Region
 - In Combination with or without Space Characters







Flexible Amount Fields Decimal Settings



- New ways of presenting "Amount fields"
 - Amount fields (field-type in Xtract) are replaced by decimal fields with the use of a Parameter to enforce the Decimal Length

Use of VIES Web Service



- Sales tax IDs can now be validated and used to complete the Supplier Information via the VIES Web Service (VIES VAT Number Validation) provided by the European Commission
 - Validation works for all member states of the European Union but the Details of Suppliers are not available for all Countries.
- Seperate UK Validation Service will be included in the next Update of the AP Package











- Restructuring of the used code to a new common Architecture
- Results in a big change of the Scripting interface
- Adding functionality to change AP parameters at runtime
- Will be sharded in the future with all AP packs
- Not touching the Platform Scripting Interface











- Easy Training Handling
- Flexibility on using decimal on Amounts
- Possibility to use VIES (VAT Number Validation of the European Commission)
- Much easier to Support in case of Customizing
- Will be the Base for all new Improvements
 - UK VAT Number Service will be included in the next Version
