

# INTERVIEW WITH BEATE KIRWA

**CEO AT HENRICHSEN4S** 



### MS. KIRWA, COULD YOU BRIEFLY INTRODUCE THE HENRICHSEN GROUP?

HENRICHSEN is а family-owned company that was founded more than 40 years ago in Straubing and was already involved in the digitalization of office work in the early days. With currently over 200 employees, 70 of whom are dedicated exclusively to the SAP market - this includes our subsidiary HENRICHSEN4s - the HENRICHSEN Group achieved a total turnover of 29 million euros in 2023. As a leading IT expert, HENRICHSEN optimizes commercial business processes for customers, with topics such as Purchase to Pay, ECM with intelligent assistants; integrations MS Dyn 365 BC, SAP; data services; cloud, Saas, hybrid; HEN-RICHSEN Cloud Platform; financial accounting and IT services firmly integrated. Around 2,000 customers, mainly in the DACH region, rely on HENRICHSEN's products and solutions.

### WHAT CRITERIA WERE DECISIVE FOR YOU TO CHOOSE IRIS AS YOUR SOFTWARE MANUFACTURER?

We support our customers with process automation and create transparency through digitalization.

## WHAT DO YOUR CUSTOMERS SAY ABOUT THE SOLUTION?

We hear again and again from our customers that our solutions offer a deep level of







integration into SAP, are standardized and at the same time allow a high degree of flexibility. We are constantly adapting our software to changing market requirements and customer wishes, so that a higher standard is always achieved. Ultimately, we want to achieve the highest possible automation rate for our customers. We also want to simplify work processes for the employees who work with our solutions on a daily basis and show them how to deal with the new. Especially when it comes to future topics such as cloud solutions or AI, we accompany this change because real and sustainable success comes with the adaptation of employees. It is also always important for us internally to align the entire team with these new topics and bring them along with us this is the only way we can be successful as HENRICHSEN. Al is a key aspect these days, but it also needs to be critically reflected upon. Al also has its limits and cannot replace humans, Which is why our customers value the technology from IRIS. The solution is supported by AI, but in the end, the human factor is still integrated into the validation and is the one who ultimately decides and thus avoids incorrect automated training.

## HOW IMPORTANT IS SUSTAINABILITY TO THE HENRICHSEN GROUP?

Sustainability has a high priority at the HENRICHSEN Group, as we firmly believe that our responsibility goes beyond the purely commercial. Our employees are our most important asset, and long-term partnerships with customers





and partners are crucial for us. This commitment is reflected in the HENRICHSEN value tree. We stand for healthy and shared growth and genuine sustainability. For measurable success and CO<sub>2</sub> savings, especially through digitalization projects. "Sustainably successful" is much more than just a slogan for us as a family business, it is a mission that we continuously pursue. We measure our sustainable success by the fact that, for example, we can save as much CO<sub>2</sub> annually through the digitalization of our customers as one person would consume on 58,465 domestic flights!

WHAT ARE YOUR GOALS FOR THIS YEAR TOGETHER WITH IRIS?

One goal for this year is certainly to make our collaboration with IRIS even more visible to the outside world. We would like to emphasize this through joint reference customers, among other things.
