Challenges included:

- Handling various document formats (PDF, JPEG, XML, E-Invoice).
- Building flexible extraction algorithms for complex data.
- Managing exceptions (tax data, currencies, invoice types).
- Achieving total automation to reduce manual validation.
- Implementing master data comparison to enhance extraction accuracy.

The goal was to ensure high automation, data precision, and scalability while maintaining compliance and minimizing manual intervention.

Results & Impact

The integration of IRIS technology enabled:

- End-to-end automation with minimal manual work
- Improved SLA compliance through better error detection and testing.
- Operational scalability and long-term performance stability.
